JUDICIARY REPORT



Thanks to the Judiciary panel members for their wisdom and attendance each Wednesday night during the season namely David Wilson, Don Gale, Cass Greco, Richard Wright, and Tony Cavalieri also thanks to the referee's representatives who helped during the meetings.

We had a few challenges this season, and only a couple of appeals. The MWFA are still bringing the Judiciary rules in line with FNSW rules and this will help to eliminate any loopholes etc.

It continues to be the majority of serious offences are in the R6 category i.e. Foul and Abusive Language mainly towards match officials. This has been the case for many years and we are at a loss as to how to stamp this out. Maybe the Referees will have to take a firmer approach to bad language and the Judiciary will have to hand out

longer suspensions.

The Special Purposes Tribunal (SPT) was convened on a couple of occasions this season, it has been established to handle cases that do not come under the jurisdiction of the judiciary for example offences by Spectators, Coaches and Managers or Clubs.

The SPT will recommend any sanctions to the MWFA EC to apply.

If anyone out there in club land would like to join the judiciary panel they are most welcome, the current panel if re-elected at the AGM would benefit from having a wider selection of club representation as some times various panel members have to stand down from a case as it involves their club, and the experience you would gain is both enjoyable and interesting.

The main changes to the competition from 2016 were:

- The only All Age teams who played first and reserves were PL, AL1 and AL2. AL3 down was played as single teams
- In the third year of the O45 competition, there were three divisions.
- The WPL did not play as firsts and reserves but as separate divisions, WPL and WAL1. Normal borrowing rules applied but WPL and WAL1 teams from the same Club were paired.
- The WU12 and WU15 were played as 14 team competitions which split after one round.

This year Easter occurred during the middle week of the April school holidays. Normally there would have been a Senior Women's round on that day. This only has a small effect on the competition as Senior Women do have extra weeks.

During the season there were regrades made after a review of the first round results:

- Wakehurst 12 Div 4 to Div 3, Avalon Div 3 to Div 4
- Wakehurst 13 Div 1 to Div 2 and Mosman U13 Div 2 to Div 3
- Mosman U14 Div 1 to Div 2, St Augustines U14 Div 2 to Div 3, Dee Why and Seaforth U14 Div 3 to Div 4
- Pittwater U15 Div 2 to Div 3 with Div 3 splitting into a 6 and 5 team divisions playing two full rounds.
- Wakehurst U18 Div 2 to Div 3 and Manly Vale Div 3 to Div 4.
- Curl Curl O35 Div 4 to Div 5 and Curl Curl Div 5 to Div 6
- Narrabeen O45 Div 1 to Div 2 and Forest Killarney O45 Div 2 to Div 3
- Seaforth WU14 and Mosman WU14 Div 1 to Div 2 splitting into two 6 team comps.

The regrades can be difficult when synchronising the number of games between divisions and splitting divisions which would not have been split.

In 2017 there was only one complete washout weekend on the June long weekend. There were some other partial washouts and one week where a partial round was played on the Saturday, but the Women's rounds were completely played. In all but divisions with more than 20 rounds all games were replayed on scheduled washout rounds. For those divisions the rounds were cancelled.

Due to the increase in the number of finals across all competitions, there was a return to the format of the Grand Finals of four years ago consisting of three Finals Days; Junior Boys, Senior Men's (including U18) and Senior and Junior Women's. Again there was no extra time played in the Finals.

1.0 - Meeting Opened: At 7.30pm by the 2016 MWFA President, Mr Jeff Smit

2.0 - Welcome:

All Life Members, delegates and guests were welcomed to the 69th Annual General Meeting of the Manly Warringah Football Association Inc. by MWFA President, Mr Jeff Smit (EC). Jeff made mention of MWFA Life Members present, Mrs Linda Ward, Messrs Don Gale, Keith Pester (EC), Ray Fanning and Andrew Edwards (EC).

3.0 - Attendance:

4.0 - Apologies:

Congratulations were extended to all the above members, and thanks offered to all of the member Clubs' Office Bearers for volunteering their services on behalf of Football in Manly Warringah.

10.0 - Treasurer's Report and Budget for 2017:

Mr Smit invited Mr Joseph Sorbara (Treasurer MWFA) to speak on financial matters contained in the Annual Report. Mr Sorbara advised that the 2016 Annual Report, contained a fully audited statement and financial documentation dated 14th November, 2016, for the Financial Year ended 30th September, 2016. This documentation, signed by CKC Corporate Services, Chartered Accountants, was noted as final. He remarked that the 'MWFA Annual Treasurer's Report and Financial Statements' were again completed according to the Companies Act of NSW and as advised by our Auditors.

Mr Sorbara noted some changes to the Budget documentation regarding proposed fees for 2017. There followed a motion from Mr Sorbara, seconded by Mr Greg Dick, to accept the Budget and Financial documentation in his Treasurer's Report. This motion was carried unanimously.

Mr Smit thanked Mr Sorbara for his work as Treasurer, over the past two years, and said we looked forward to his continued service.

11.0 - Honorary Auditor:

There followed a vote to accept the 2016 Auditor ('CKC Accountants') as the Honorary Auditors for 2017. The Motion was moved by Mr Smit (EC), seconded by Mr Edwards (LM & EC), and passed unanimously.

12.0 - Election of Public Officer:

Mr Smit then stated Mr Jeremy Toivonen (MWFA General Manager) had been nominated and seconded as the Public Officer for the MWFA so he was duly elected, unopposed.

13.0 - Affiliation of Clubs:

Mr Toivonen stated all Clubs had affiliated.

14.0 - General Business

14.1- The 2017 Budget

Mr Smit said the Budget as tabled may have to be adjusted slightly to cover minor items but would remain substantially as tabled tonight.

14.2 – MWFA Governance

Mr Smit again explained this ongoing matter, with further meetings to determine future action. There was mention of the interim report completed with five main areas for the MWFA and stakeholders to determine. Mr Smit stated the overall aim was to pull all MWFA sections into tighter governance procedures. Such matters as corporate governance, assistance with management and risk management were highlighted to be determined prior to the 2017 season being in full swing.

Next was mentioned the need to have Coach Development greatly enhanced and to rename the Coaching Director under the title Community Coach Manager (or such altered title as determined). There was to be an advertisement this week to seek such a person for the role who would work closely with Clubs and liaise with the MWFA.

14.3 – Notice of Motion – Proposed Amendment to Playing Rules

Mr Edwards spoke on several playing rules to be refined to fit the development of the Player Grading system. This was noted as P1 to P7 in amendments proposed and was outlined and explained by Mr Edwards. After much discussion Mr Edwards stated any vote tonight would still be able to be amended in wording up until and including the March 2017 Council of Clubs meeting if necessary. With discussion concluded the sections were passed in the majority.

Section P8, regarding the frequency borrowing of U16 and U18 players into PL and AL 1 teams was also passed

14.4 - Additional Playing Sections

Ms Louise Walker (VP Girls and Women's Football) sought an extension of Under 7 girls to participate in the 'MiniRoos' regime other than only in the mixed teams should that be desired.

Ms Walker also suggested that there may be more match sharing with other Associations to promote women's football.

Next Ms Walker stated that not many Clubs were able to have full WPL/WPLR squads. She stated her desire to grow the competition which may require moving from WPL/WPLR squads to WPL teams and separate WAL 1 teams. This matter would be put to Clubs to discuss and then decide.

14.5– Matches and Referees

Mr Edwards spoke on the continued search for more referees and some ideas to have different ages/divisions play on Friday evenings to help free up players for becoming referees. Different age groups were suggested and discussed. Further discussion would occur from now on. There was a suggestion of Under 12's playing 9 –a-side matches but this was determined as not following FNSW guidelines.

14.6 – Football on the Northern Beaches:

Mr Smit raised the matter of having a governing body to promote football on the Northern Beaches and suggested Mr David Tomlinson (MWFA Life Member and former MWFA Treasurer) as a suitable person to chair this Sub-Committee in the interim until a meeting is arranged and processes established to elect a full committee of Management plus a Chairperson.

15.0 – 2017 Annual General Meeting

Mr Smit announced the date for the 2017 AGM was set as Monday, 27th November, 2017.

16.0 - Meeting Closure:

Mr Smit thanked all for attending and closed the 2016 Annual General Meeting at 8.35pm, mentioning the efficient way tonight's AGM was conducted and wishing all a Merry Christmas and a Happy and Prosperous New Year.

He invited all to attend the first 2017 Council of Clubs Monthly Meeting on Monday, 6th February 2017, starting at 7.30pm.

Finally, he asked all present to stay for some refreshments to end a busy yet successful 2016 season.

PROPOSED MWFA CONSTITUTION CHANGES 2017 PART 1

PLAYING RULE CHANGES

PLAYER GRADING COMMITTEE RECOMMENDATIONS

Amendment P1:

Replace sentences in italics:

A7 PLAYER GRADING AND QUOTAS

(b) Playing History

Any player who was not registered with a MWFA Club in the immediately previous football year must provide a history of their football participation to the MWFA. This is provided on the MWFA form.

As a minimum this history must be for the previous five years and include the Club, Association/ League and Country for any football team in which they have played.

If a player provides a false Playing History, the player will immediately be deregistered and the EC will determine when the player may be re-registered.

A player will not be registered until their Playing History is provided which contains the minimum required history.

With the sentences in italics:

A7 PLAYER GRADING AND QUOTAS

(b) Playing History

Any player who was not registered with a MWFA Club in the immediately previous football year must provide a history of their football participation to the MWFA. This is provided on the MWFA form.

The player must provide a playing history for the previous five years and include the Club, Association/ League and country for any football team in which they played.

The Registering Club may make a submission to the PGC for an exemption from a Grade being applied and/or which Grade should apply, if any.

If the PGC is not satisfied with the information they may send it back to the Registering Club to provide further information, a decision on the player's grade will only be made when the PGC is satisfied that all information has been presented.

If a player provides a false Playing History, the player will immediately be deregistered and the EC will determine when the player may be re-registered.

A player will not be registered until their Playing History is provided which contains the minimum required history.

Amendment P2:

Replace portion in italics:

A7 PLAYER GRADING AND QUOTAS

(c) Player Grades

For all players required to provide a Playing History, the PGC will determine if a Grade is to be assigned to the player and if so what Grade is assigned.

The following Grades will be used:

Grade 1: Equivalent to A league Standard

Grade 2: Equivalent to NPL1 standard

Grade 3: Equivalent to NPL2 standard

The assigned Grade is not solely determined by the Player's team registration in the immediately previous football year and, as a minimum, the previous five years Playing History will be taken into account.

The PGC may take into account the MWFA Club of Origin of the player in determining if a Grade will be assigned. If a player wishes the PGC to take into account evidence of previous Playing History they must provide such evidence.

The PGC may take into account the competition, age group and division into which the player is registering and the last competition, age group and division played.

The PGC will determine the Grade for overseas and interstate players registering in the MWFA and will establish the equivalence of the respective overseas leagues to FNSW competitions.

The Registering Club may make a submission to the PGC for exemption from a Grade being applied and/or which Grade should apply, if any.

With:

A7 PLAYER GRADING AND QUOTAS

(c) Player Grades

For all players required to provide a Playing History, the PGC will determine if a Grade is to be assigned to the player and if so what Grade is assigned.

The following Grades will be used:

Grade 1: Equivalent to A league Standard

Grade 2: Equivalent to NPL1 standard

Grade 3: Equivalent to NPL2 standard

The assigned Grade is not solely determined by the Player's team registration in the immediately previous football year and the Playing History provided above will be taken into account. The Grade will be determined according to the MWFA PGC Grading Guidelines as defined in clause A7 (j).

The PGC may grant an Exemption for a Graded Player to register in a team at an MWFA Club irrespective of the assigned Grade.

An Exemption will only apply for the Football Year in which it was granted apart from where a player is re-registering in the Club of Origin.

If an Exemption is granted the Player is assigned a Nominated Grade which is the Player's assigned Grade before the Exemption is granted.

If the Player re-registers for another MWFA Club or transfers to a different team in the same MWFA Club, the Nominated Grade will apply to the player unless another Exemption is granted by the PGC.

Amendment P3:

Delete portion in italics:

A7 PLAYER GRADING AND QUOTAS

(d) Retention of Grade:

The Grade of a player is retained independent of the MWFA Club in which they registered.

A player who is initially given a Grade 1 retains that grading for two football years before dropping to Grade 2 for a further two years.

A player who is initially given a Grade 2 retains that grading for two football years before dropping to Grade 3 for the third year.

A player who is initially given a Grade 3 retains that grading for two football years.

This is irrespective of them being registered with the MWFA in intervening football years.

Add the words in italics:

A7 PLAYER GRADING AND QUOTAS

(d) Retention of Grade:

The Grade or *Nominated Grade* of a player is retained independent of the MWFA Club in which they registered.

A player who is initially given a Grade 1 retains that grading for two football years before dropping to Grade 2 for a further two years.

A player who is initially given a Grade 2 retains that grading for two football years before dropping to Grade 3 for the third year.

A player who is initially given a Grade 3 retains that grading for two football years.
